RE: Essential and Critical worker status of corrugated packaging industry

Dear Prime Minister:

We are contacting you on behalf of the Canadian Corrugated & Containerboard industry which supplies corrugated cardboard packaging materials to customers of every kind, in every province of Canada. Our supply model includes mills that produce the roll stock materials and a wide range of converting plants to make finished packaging, all in the form of corrugated paper material. We also use the recycling infrastructure to support industry, retail and residential related needs. The industry has 55 plants in total and employs well over 10,000 people to support the Canadian marketplace.

The impact of the COVID-19 virus is severe; a generational disruption to our life, our economy, our country and the world. Efforts and leadership provided by you and your government colleagues are recognized as extremely credible on everything to date.

With the many directions the pandemic may take, this letter wishes to outline that our industry is essential to the supply chain of the many customers we serve across this great country. A corrugated cardboard box is taken for granted in many ways – until or unless it is not available. Food manufacturing of all sizes, home delivery services, pharmaceutical shipments and literally every product on a supermarket shelf is shipped in a cardboard box.

The concern our industry leadership shares is that government may consider some form of curtailment of activity in manufacturing to support social distancing issues. We beseech you to identify our industry as essential and critical thus allowing us to serve customers without interruption. We commit to full conformance of all responsible social distancing and health management requirements prescribed.

The U.S. Department of Homeland Security issued a memorandum yesterday that outlines this. This request is to align our position with the United States.

You need us more than you may know. Our customers need us on a daily basis. We ask you to provide the continued freedom to meet those needs. There are many industries larger than us, but that is not an indication of importance.

Thank you for maintaining border access with the United States for commercial purposes. That link is vital for the daily movement of containerboard mill stock to the converting plants.

The Association and its Board of Directors listed below are committed to help in any way possible. Keep up the strong effort and leadership.
